## 2024 Freedom & Music Festival review

Discussed the positive changes that were made this year that we will continue to do and what we'd like to change for next year. Event almost completely self-funded this year! Listed some things to work on or look into:

- -reconfigure the vendor layout to allow better visibility and flow for everyone, but location was great by the food tent. Move portapots to east parameter (near food tents, but away from food vendors)
- -review vendor contracts and tighten up specifics in wording, insist on them providing correct info or links to their website, page, or email to aid us in advertising as part of the completed application
- -food vendors must be available for both days of the festival, and all vendors must be setup for their contracted times or forfeit their spot
- -look into a gluten-free alcohol option such as a hard cider; reach out to local bar owners to see who their suppliers are and what they'd recommend as a popular choice
- -move July 4 parade to 11:00am and begin that day's event at noon by removing one act to fit the schedule
- -continue to build on the kid/teen entertainment and activity portion, keep watermelon eating contest and make that a spotlight activity (no other big things going on during that time so we can increase attendance- more adults got in on it this year and we can assign business sponsored prizes for each age category) -secure large corporation sponsors early on in the year or look into their requirements for when to submit requests to bridge the gap from what we receive from our local businesses
- -work with Charlies on setting a monthly bingo night to help raise funds throughout the year
- -look into boosting internet/wifi signal outside to help vendors and our equiptment

## Community Picnic planning

- -Date is set for Saturday August 17, 11:00am-2:00pm at the Village Park with the splash pad turned on.
- -DJ Firework booked to entertain 11:30-!:30 and Rec Board will offer hotdogs, chips, cookies and drinks to residents and have some yard games set up.
- -A mailing will go out to all the Homer Village and Township residents inviting them to bring their chairs and hang out for a while.
- -Costs for mailing were generously donated by the South Homer Township,
- -Frito-Lay donated the boxes of chips, and Coke supplied the water and Powerade.

- -Elizabeth is donating her time and materials to make backpack door prizes for the kids and we're using some funds to purchase gift cards to local businesses for the adult prizes.
- -We wanted to hold a bingo fundraiser that same night at Charlie's but we are still waiting to hear back from the owners on their premise license. Looking at setting a bingo fundraiser night on the 1st Saturday of each month pending location restrictions.
